MANAGEMENT COMMITTEE CHAIRMAN'S REPORT

2013 has been another good year for the work of the Trust. We have consolidated the good work of the past few years, and at the same time we have made strides in growing the different projects at Westlake.

Emmanuel Educare is virtually at full capacity in terms of the school's complement of children (200). Similarly, the Home-Based Care team, while possibly being able to employ two more carers, is almost at a staff maximum of 25. The Board took the decision to apply to SARS to have Emmanuel Educare registered as a separate Public Benefit Organisation (PBO) in 2014. The school will still operate under the auspices of WUCT, but will have its own constitution. The Trustees also took the decision to start a pension fund for the staff.

The staff of 55 has taken WUCT forward on the fronts, as David Barnes, our Manager keeps reminding us, of Education,

Community Advice and Health. I refer the readers to the detailed reports of these departments. We are blessed to have Time and Labour Consultants manage our HR matters which, with a staff of fifty five, is essential in an operation of our size.

We very sadly lost one of our Trustees last year. Angus Wilson, our CHS representative, died suddenly on 11th October. David Walsh has agreed to take his place on the Board of Trustees. Ann Albrecht, Brian Fraser and Carol Mouton were accepted as new Trustees during the year. Ann was a new addition and Brian and Carol replaced Rev Kevin Daines and Rev Floors van Rooi. Kevin and Floors, thank you very much for your contributions during

the years you both served on the Board.

Thanks to all the new Trustees for agreeing to get involved in the work here in Westlake.

Jamie McGregor has, despite his ill health, continued his involvement, and for that we are deeply grateful.

Finally, may I draw your attention to David Barnes' final comments in his report, where honour and thanks is given to our Lord Jesus Christ. David says "We serve, because we follow Jesus' example. We care because we want to show Jesus' compassion and concern for those who are not so fortunate in life" His blessing has been on the work at Westlake and for that we give Him thanks.

May I also say a big thank you to the WUCT staff and all who voluntarily give of their time and to all who have supported the work financially. We greatly appreciate your interest and sacrifice.

MANAGEMENT COMMITTEE REPORT



We give thanks to God for steering the Trust through another year, marked by difficult fundraising conditions common to most NPOs.

That we achieved a R3.7 million budget is a credit to all who were involved in fundraising of whatever sort. These included a business breakfast and a night at the Masque Theatre. We thank Jo Manzi for these initiatives.

The Provincial Departments of Social Development, Health and Education are to be thanked for their continuous support, as well as the Community Chest, the National Lottery and the City of Cape Town.

Emmanuel Educare finally has its edutainer in use after long negotiations with the fire department. This means that the school is almost at its full complement of 210 children.

We have been approved by SARS for Emmanuel to be a separate NPO and PBO with Section 18 approval. We feel this makes sense and that it will please the government funders, as well as the Lottery. This takes immediate effect from 1 April 2014.

All other departments have worked well and made progress in serving Westlake Village during the year. The Advice Office, which now runs the second-hand shop, has been particularly active, as have those who do sewing and beading. The premises have been used throughout the year with rentals of almost R200 000 received, all of which helps finance the Advice Office. Internally generated funds now total approximately 25% of the Trust's total income. This

is important in terms of long-term sustainability.

The Home-Based Care department with its team of 21 caring for over 400 patients has, as always, delivered an outstanding service.

Similarly, the Child Care and Protection department, funded by the Dept of Social Development, has innovatively provided psycho-social support to 30 OVCs from Westlake Village.

Finally, a big thank you to the entire staff of the Trust, you are a real credit to this organisation. The role of Dave Barnes as the Manager has been particularly valuable and vital to everything that happens at the Trust.

COMMUNITY ADVICE OFFICE REPORT

Another year of serving the community has gone by and with much activity in the Office. Numerous faxes, CVs and typing were done for community members.

Our office rented out rooms and space in the Centre for meetings, training, church services, weddings and funerals.

Home Affairs

People were assisted where fires demolished their homes and also with application forms where folk had to re-apply for documents.

Disaster Management partnered with WUCT and assisted with building materials for those who lost their homes to fires.

"Mandela Day" 2013 was a real highlight with the Community Centre abuzz with activity, some of which are listed below:-

- Nutri Pharma Solutions fed 300 children with sandwiches and fruit on Mandela Day.
- The EES Company painted the Community Advice Office and Home Based Care office.
- Virgin Active Steenberg staff painted the office block entrance area and passage.

- American Consulate staff upgraded three homes in the village to make them more liveable.
- Tafelberg Furniture donated three mattresses.
- Westlake False Bay College donated clothing for our second-hand shop.
- Hearshaw & Kinnes donated fruit to our chronic support group and children.
- M.J.M. Minter Accountant in Tokai treated WUCT staff with muffins.

Flooding in Westlake

WUCT assisted members of the community with sand bags to prevent the water damage to their shacks during the heavy down-pour in June 2013. Blankets, clothing and food parcels were also given to the community.

Employment

The Office helped two hundred and twenty one people to find temporary and permanent employment during 2013. The following companies and organisations employed Westlake residents: Silver Mine Conservations, Zucci Waters, Yuppi Chef, Water Conservation Works, Department of Social Development, Parks and Forest Newlands, Constantia Valley, Sub-Council 20 ward 71.

Three physically challenged people received employment

from Metropolitan Head Office in Bellville.


We are indebted to Cadiz Asset Management for the supply of beautiful office furniture. Thank you very much!

HOME-BASED CARE REPORT

2013 – Another year has flown past with various activities, events and outreaches involving this department.

Our home-based care team of twenty two includes a Professional Nursing Sister/Co-ordinator, a Facilitator of the Chronic Diseases of Lifestyle (CDL) support groups, two Community Care Workers who monitor ARV and TB treatment in the community, nineteen carers and an Administrator. We provide an integrated home-based care service to the Westlake community, as well as the surrounding suburbs as far as Plumstead, including two Communicare Homes – Dreyersdal Park in Bergvliet and Musgrave Park in Diep River. In addition to providing home-based care to sick and frail people in their homes, we also run six CDL support groups and two HIV support groups (one for adults and one for children), a TB/HIV Integration Programme, and attend to wound dressings. We send our carers on training courses to improve their skills. Our client base as at end of Dec 2013 was four hundred and thirty seven, and we had an average of twenty patients per month receiving wound care. The carers carried out on average between 90–100 visits per month.

In January, seven of our staff members assisted City of Cape Town Health Directorate and Westlake Clinic, with HIV Counselling and Testing at False Bay College, Westlake campus, which is situated next door to us. 55 students were tested for HIV in a morning. The results were 54 HIV negative and only one positive. Our carers also monitored blood pressures and blood sugar levels.

It was a great success and started a good working relationship with City Health and False Bay College.

In March, we sent two members of our home-based care team, Joseph Mphala and Nancy Mkundlu, to join MSAT South's World TB Day event at Imizamo Yethu squatter camp in Hout Bay. Living Hope carried out HIV testing in three tents. Eighty two clients were screened in three hours! Nancy together with other members of MSAT South assisted with BMI screening and Joseph distributed TB information leaflets, condoms and masks.

MSAT (Multi-Sectoral Action Team) is a City of Cape Town initiative to encourage NPOs working in the Southern Sub-District to network and run awareness events to fight the spread of HIV/Aids and TB.

In May, the Rotary Club of Constantia partnered with Metro District Health Services, the City of Cape Town, Department of Health, WUCT, Compassion in Action, Environmental Health and Westlake Clinic to bring free health services to the Westlake community over three days at our hall.

Rotary Family Health Days were held at one hundred and eighty sites across the country at the same time. Our site provided free TB testing, diabetes and blood pressure screening, BMI, HIV counselling and testing, polio and measles vaccinations and deworming, vitamin A drops

for children, information on male medical circumcision, cancer awareness, eye testing and general hygiene and health education.

Over 200 people were seen in the three days.

The eye testing was the most popular station – 88 people had their eyes tested by Alan Wise Optometrist from the Westlake Lifestyle Centre. Seventy five people needed glasses and five medical attention. It made everyone realise what a huge need this important service is in the community. A huge thank you to Alan Wise, who gave up two days to come and do the testing for the residents of Westlake community who do not often have the opportunity to have their eyes tested.

In July, our Westlake, Uitsig, Musgrave Park and Dreyersdal Park Chronic Diseases of Lifestyle support groups had an indoor sports day in the Community Centre hall. There was much laughter, singing and war cries as everyone participated in the various events – egg and spoon races, etc. Congratulations to Beatrice for organising an awesome morning for our elderly people who had lots of fun and certainly had their exercise for the day!

In November we held a World Aids Day event in the park in the village, together with Westlake Clinic. It was a great success and people were queuing up, despite the wind blowing a gale. We managed to test 35 people, do blood pressure

and blood sugar monitoring and TB testing, before we had to pack up before the tents blew away.

We also took part in MSAT's World Aids Day event in Parkwood in December. HIV testing, BP and blood sugar monitoring were done and it was another successful event. Altogether seven organisations worked together with City Health. (Kindly refer to our website for photos of all the above activities.)

There were many other highlights during the year such as the Spring Day event/fashion show in the hall for all the CDL support groups, and the Care for the Carer event held at Common Ground Church, Rondebosch, where our carers were entertained and thoroughly spoilt with delicious treats and personalised gifts. We were also delighted that Veronica Weier, our Community Healthcare Worker, received a Community Award for the work she does in Westlake from Councillor Penny East, Sub-District Council 20.

I would like to thank:

- Christ Church Constantia for their regular donation of blankets, clothes and Christmas hampers.
- Joyce Meyer Ministries for the monthly wonderful food parcels, which are so appreciated.
- Mountain View Baptist Church for the toiletries, towels, linen and clothes for our patients.
- St Martin's Church for their financial contribution, as well as clothes and other goods.
- Catholic Church Constantia for the very generous donation of 10 blood pressure and blood glucose monitoring devices.
- All the other churches and individuals who assist us with the work we are doing in this department. We are truly blessed and thank God for everything He does through so many kind and generous people.

Finally, I would like to thank the Department of Health for their support and our wonderful team of carers for all their hard work and for going the extra mile to help and care for patients, always happy and friendly, at the same time offering a professional service to the communities we are serving. You are all amazing! Thank you, Alastair, for all the admin work, with the huge volumes of forms to complete!

SOCIAL DEVELOPMENT REPORT



This department consists of a Co-ordinator and six Fieldworkers who run psycho-social support groups for our orphans and vulnerable children (OVCs), who are infected or affected by HIV/Aids, or are abandoned, neglected, fostered or staying in emergency safe houses. The programme is funded by Department of Social Development under their Child Care and Protection Programme. The support groups are formed into groups of ten children each and are run in the afternoons after school. The fieldworkers attend Khululeka training workshops focussing on grief and loss.

2013 was another action-packed year, starting in January with a camp at the Rotary site in Glencairn, Simon's Town. Fourty two of our OVCs attended and five members of the community did the catering. The theme was "New Beginnings" focussing on coping skills and how one can start a new life after the loss of family loved ones. Benita Barnett and our incredible team of fieldworkers ran an excellent programme and the children played games and had fun

swimming in the pool, and needless to say enjoyed delicious meals! This was the first time some of the children had been out of Westlake the entire Christmas holidays so it was such a treat for them. We hope to make this an annual event.

On Mandela Day, 18 July 2013, amongst all the other activities going on at our Community Centre, we held a party for our OVCs who had birthdays, as well

as to celebrate Madiba's birthday. Arlene and the team decorated the meeting room upstairs – it was transformed with pictures on the walls, balloons, etc and the children had a wonderful time! Brenda September made a beautiful birthday cake and they all blew out the candles together. Well done, Arlene, and thank you to the team who worked so hard to make it such a memorable occasion for our OVCs.

ADULT EDUCATION AND TRAINING

During the July holidays, 10 of the OVCs attended Christ Church Constantia's holiday club for a week and had a good time. Thank you, Christ Church, for thinking of our children!

In October, the children attended a fun-filled day run by Sisanda FunDaytion at the Waterfront. There were many surprises, including a boat tour aboard Tommy Tug Boat, a spin on the Big Wheel, playing and singing, eating a Spur burger meal and finding a giant Treasure Chest cake, all along whilst dressed as pirates. One of the little girls ran around shouting 'Ahoy!' to all the boat captains and anybody passing by. WUCT contributed towards a healthy breakfast, drinks and snacks.

Finally, I would like to thank everyone who has donated clothes, toys, books, etc to our OVCs, Judy Lambrecht and friends for the wonderful Christmas presents, Orphan Care Foundation for their ongoing assistance, and all the churches and individuals for their support towards the work we are doing in this department. These vulnerable children are in need of many things, school books, stationery, shoes, clothing, and we really appreciate your contributions. Thank you, especially, to God for the team and for all their hard work, even working overtime to give these children much needed love, guidance and support.

EMMANUEL EDUCARE

Emmanuel Educare enjoyed a happy and productive year, and it was a joy to welcome the children here each day. We were proud to bid farewell with encouragement to those who had completed their time with us, and look forward to good reports on their progress in the years to come. Our Governing Body was ably led by Beulah Matthyse, and we thank her for the time she gave up for us during the year.

Our school roll increased from 194 to 206 learners in 2013. After much wrangling with the powers that be, we were able to start a new Grade 0 class in the refurbished Edutainer. Many thanks to David Beyers of St Martin's Church for all the work he put in to get the Edutainer up to standard and in obtaining approval from the City Council.

There were several staff changes, the most notable being assistant teacher Pauline Vers, who left the school after 10 years of service. She has gone to join her husband in Tsitsikama. She was replaced by Avuzwa Dumezweni, and at the beginning of 2014 Yolanda Komani, Thembakazi Dlangudlangu and Zondrea September joined the staff as assistant teachers. We bade a sad farewell to Tanith Muller, our volunteer ballet teacher, at the end of the year.

Instead of inviting sponsorship for individual learners, the pre-school inaugurated a bursary fund to assist those in financial need. Qualifying parents (those with a joint income below R3 000 per month), were

invited to apply. By the end of the year we had 35 children on the bursary scheme. Many thanks to those donors who supported the scheme – without your generosity we would not have been able to achieve this.

There are so many who we need to thank for their support. As always, Pick n Pay and Woolworths have assisted us with provisions. We received donations of Easter Eggs from Reddam Preparatory School and also from Kirstenhof Primary. Reddam High School, together with visitors from Reddam House Australia, visited Emmanuel Educare and provided every child in the school with a pair of shoes and socks. What a fantastic donation this was.

Yuppie Chef, a company in the business park, provided sandwiches, and we also receive a weekly donation of bread and spreads from the learners at Reddam Prep. The bursary fund has been the recipient of various generous donations from friends of Emmanuel. A donation of paper and paint was received from the Hydrographic Office of the Navy. Two hundred knitted blankets were given to the school by Tokai Methodist Church. Chatz cellular, on Mandela Day, provided Kentucky Fried Chicken for all the children. Thanks are also due to Mea Lashbrooke for gifts including some wonderful little plastic scooters.

At the end of the year, the staff received generous gifts from Christ Church Constantia, and our learners from Tokai Methodist Church and the Steenberg Golf Club. The learners were also delighted with

an outing to Reddam House School. Rose Fox, from Church of the Holy Spirit, provided piano support for the Nativity Play, the highlight of the year, which was very well supported – so much so that many had to be turned away owing to fire and safety regulations. This left many disappointed. In 2013 Councillor Penny East & WUCT Trustee Nkululeko Badini handed out the certificates which was followed by the Nativity Play.

Jodene Roberts was one of our first pupils at Emmanuel Educare. She showed great potential as a minor and has gone on to demonstrate this by winning countless prizes at Westlake Primary School. Her academic prowess has taken her to Norman Henshilwood School which she now attends. We are all very proud of Jodene and others who have achieved well scholastically.

To all those whose support and prayers assist us in growing from strength to strength, our grateful thanks. May the Lord bless you in the knowledge that you are contributing in such a meaningful way to the lives of others.

Independent Auditors' Report

To the trustees of Westlake United Church Trust

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion paragraph, the annual financial statements present fairly, in all material respects, the financial position of Westlake United Church Trust as at 31 December 2013, and its financial performance and cash flows for the year then ended in accordance with the International Financial Reporting Standard for Small and Medium-sized Entities.

The trustees acknowledge that they are ultimately responsible for the system of internal financial control established by the trust and place considerable importance on maintaining a strong control environment. To enable the trustees to meet these responsibilities, the board sets standards for internal control aimed at reducing the risk of error or loss in a cost effective manner. The standards include the proper delegation of responsibilities within a clearly defined framework, effective accounting procedures and adequate segregation of duties to ensure an acceptable level of risk. These controls are monitored throughout the trust and all employees are required to maintain the highest ethical standards in ensuring the trust's business is conducted in a manner that in all reasonable circumstances is above reproach. The focus of risk management in the trust is on identifying, assessing, managing and monitoring all known forms of risk across the trust. While operating risk cannot be fully eliminated, the trust endeavours to minimise it by ensuring that appropriate infrastructure, controls, systems and ethical behaviour are applied and managed within predetermined procedures and constraints.




